It is our pleasure to welcome you to the 2023 annual conference and AGM of SASFF and the second AGM of the SA Student Finance Forum NPC here at the Coastlands Umhlanga Hotel in the pretty setting of the coastal town of Umhlanga Rocks in KZN.

We must assume that the SASFF is just growing from strength to strength, as in 2022 there were 116 delegates and speakers, whereas this year we have pre-registered a record of 140 delegates and speakers, representing 29 higher education institutions, one gold sponsor, six silver sponsors and associate members.
